

#### Report of the President

#### **Depot Park Project**

The multi-phased Depot Park project formally concluded when renovation of the Freight House was completed in 2009. However, Bedford continues to undertake smaller projects to improve the Depot Park complex. In September, the Facilities Department awarded a contract to a contractor to paint the Depot exterior in the same B&M "cream and maroon" color scheme as the Freight House. The Depot Park Advisory Committee, chaired by Joseph Piantedosi, is recommending a medium-range goal to renovate the Depot's facade so that it better resembles its original appearance, and that a ramp be added for improved accessibility. A complete building restoration, which would involve removal of the second floor, was estimated in 2007 to cost about \$1 million.

#### Freight House

Under a non-exclusive license issued by the Town of Bedford, FBDP opened the Freight House to the public on weekends during the months when the Minuteman Bikeway was substantially in use. Mild weather during late 2011 prompted us to keep the Freight House open on weekends through the fall and until the last week of December. The Freight House resumed a steady weekend schedule in early April of this year.

The license stipulates that proceeds from the sale of food items be conveyed to Bedford to help pay for Depot Park's operating expenses. In January, treasurer Marcia Sternberg transmitted to the municipality \$4,380.91. This amount represents the proceeds collected in calendar year 2011 from food sales, donations made by railroad car visitors, and proceeds from sales of the DPW's bikeway map.

Volunteer shopkeeper coverage was provided by Christine Bahtiarian, Sam Eickstedt, Jim Shea and Marcia Sternberg. Coverage was supplemented during a portion of 2012 by a contractor who was provided to FBDP through an employment services company.

While volunteering at the Freight House, I heard numerous compliments from visitors about the Freight House, Depot Park complex, railroad car and historical displays. The Freight House has become a valuable destination for many people who use the bikeway and/or are interested in our local history. Many families and individuals make trips from out of town to visit Depot Park—and I have noticed that many of them return on a recurring basis.

Last December, vice president Bill Deen wrote a letter to the membership to request donations in support of hiring part-time shopkeepers in 2012. The response exceeded our expectations and the directors are most grateful to the donors. I think with an additional round of fundraising during the upcoming months, FBDP will be in a position again in 2013 to hire people as needed to staff the Freight House on weekends.

#### Rail Diesel Car 6211

The cosmetically restored ex-Boston & Maine Rail Diesel Car continues to be an important focal point at Depot Park. It is usually open for the public to tour when the Freight House is open on weekends. Many people have said positive things about the car and its historical displays. Also, Bedford has rented it several times for private functions.

Added to the car this year is a TV monitor that displays a 12-minute loop of RDCs operating on the Boston & Maine during the 1960s and 1970s. This historic footage was filmed by member John M. Boardman. More recently, a device was placed inside the car to allow visitors an opportunity (for a 25¢ donation) to ring the car's electric bell.

#### **Depot Park Revolving Fund**

At Bedford's Annual Town Meeting in March, voters approved an article to continue a revolving fund for Depot Park. This account is under the control of the Facilities Department and is intended for Depot Park expenses and future enhancements. The fund's income comes from rent collected from Depot tenants, proceeds from Freight House food sales and rentals of RDC 6211. The fund's balance as of October 1, 2012, is \$37,715.43.

#### **Merchandise Sales**

Sales of goods—literature, videos and apparel—are an important means for raising the finances that FBDP needs to function. In addition to sales that occur at the Freight House, FBDP continues to receive many orders through its online store (www.BedfordDepot.org/store). So far this year, 95 web orders have been received from people across the country.

Merchandise from the Bedford Historical Society and the Bedford Minuteman Company is sold on a consignment basis at the Freight House. FBDP retains 15% of each sale to help pay for FBDP's operating and credit card processing expenses.

#### Newsletter

The *Bedford Depot News* newsletter continues to share interesting articles and research about our local railroad history and news about local rail-trails. Four more issues were published

during the past year at an average cost of approximately \$325 per issue for printing and postage. Thanks go to Marcia and Peter Sternberg for preparing each newsletter mailing.

Recently, Bill Deen and Marcia Sternberg initiated a project to index the articles that have appeared in back issues of the newsletter. They would appreciate the help of members to make headway on this useful task.

#### **Board of Directors**

The Board of Directors is comprised of the four elected officers plus the two directors atlarge. Jim Shea is the chairman and Meredith Clark is the secretary. The Board of Directors met five times during the past year to conduct long-term planning and to oversee FBDP's financial and legal affairs. The approved minutes of these meetings are posted on FBDP's web site.

At the 2010 Annual Meeting, the membership approved changes to Article Five of the Bylaws to establish the addition of two director at-large seats on the Board of Directors. Jeffrey Lucas is now serving a second term in this capacity. One seat is currently vacant. Any member who is interested in serving as a director at-large is encouraged to contact Jim Shea.

#### **Photographic Additions**

Jim Shea has continued to make trips to the Beverly Historical Society to scan photographs of the Lexington and Reformatory Branches taken by the late Albert G. Hale. Several of these images are now displayed on the video monitor inside the Freight House and been published in the newsletter. During the Annual Meeting, some of these rare photos will be displayed.

#### Billerica & Bedford Railroad Book

FBDP assisted Donald Ball with research and historical documents in support of his hardcover book, *George Mansfield and the Billerica & Bedford Railroad*. This excellent book is available for sale at the Freight House and through FBDP's online store.

#### **Indexing of Historical Records and Photographs**

This year, Bill Deen began a project to index FBDP's media assets in a computer database. These records include photographs, slides, negatives and video and audio recordings. Later, the project is to be extended to paper records that are of historical significance.

#### **Special Committees**

Under Article 6 of the Bylaws, the president may appoint members to "special committees" and "task forces" for a term of up to one year for the purpose of carrying out specific tasks. A brief description and the membership of each special committee or task force follows.

Barry Sampson has chaired the **Hobby Show Committee**. The committee's purpose is to represent FBDP at shows and exhibits where our merchandise may be sold. Barry has been unsuccessful in obtaining assistance from members to attend shows this year.

Arthur Ellis chairs the **MacLean Model Railroad Committee**. The committee's purpose is to restore, install and maintain an HO-scale model railroad layout of Bedford inside the Freight House. This layout was donated to FBDP in 2002 by the family of the late Donald MacLean. Please see Arthur's report on page 14.

Donald Corey, William Deen and Jeffrey Lucas were appointed to a **Task Force** to study the organization's possible future directions, particularly the question of whether to continue operation of the Freight House, and to make recommendations to the Board of Directors.

William Patton, Jeffrey Lucas and William Deen have advocated that FBDP publish a book that chronicles the history of the Lexington and Reformatory Branches and conveys the oral histories that FBDP has gathered over the years. This possible project might prompt the formation of a future special committee.

#### **Ongoing Tasks and Future Goals**

- ▶ Motivate members to become volunteer Freight House shopkeepers
- ▶ Find at least two members to become officer candidates at the 2013 Annual Meeting
- ▶ Appoint a member to an at-large seat on the Board of Directors
- ▶ Catalog historical documents and photographic, video and audio assets
- ▶ Make digital backup copies of photographic, video and audio media
- Leave to organize FBDP's financial, Board of Directors and corporate records
- Publish a book about the former B&M Lexington and Reformatory Branches
